LIMITED WARRANTY

FIVE YEAR HULL WARRANTY

Southern Fiberglass Products, LLC warrants to the original retail purchases of each new Southern Fiberglass Products, LLC boat that under normal use the hull will be free from structural defects for a period of five years from the date of delivery to the original retail purchaser when purchased through an authorized Southern Fiberglass Products, LLC dealer. Any structural defects covered by the warranty will be repaired free of charge at either the Southern Fiberglass Products, LLC factory in Bailey, North Carolina, or at an authorized Southern Fiberglass Products, LLC dealer location as elected by Southern Fiberglass Products, LLC. Transportation to and from the point of repair will be the responsibility of the owner with all repairs subject to prior written authorization by Southern Fiberglass Products, LLC. NO BOAT IS TO BE SENT TO SOUTHERN FIBERGLASS PRODUCTS FACTORY WITHOUT SUCH WRITTEN AUTHORITY.

EXCLUSIONS

This warranty specifically does not include the following:

1. Damage caused by abuse, negligence, vandalism, lack of maintenance, improper storage, accident, improper trailering, or natural disaster.
2. Any statements, representations, or warranties given by dealer or other third persons other than those provided within this warranty.
3. Any unit which is part of a rental fleet, used for racing, altered or modified.
4. The following consequential damages: a) loss of time, b) inconvenience c) towing charges d) expenses for travel, lodging, telephone, and gasoline, e) loss or damage to personal property or loss of revenue, f) loss of use or the boat
5. This warranty specifically does not apply to engines, outdrives, propellers, controls, mechanical steering, pumps, cracking, gel coat crazing, gel coat blistering or fading, chrome, windshields, glass breakage, all vinyl upholstery and canvas, instruments and gauges, and leakage around windshields, windows, hatches, and other apertures.
6. Any boat which has been overpowered or overloaded according the maximum US Coast Guard and Southern Fiberglass Products, LLC. recommended engine horsepower specifications on the capacity plate affixed to the boat.
7. Any product not manufactured by Southern Fiberglass Products, LLC. These products would be covered by their own manufacturer's warranty of such parts.
8. Purchaser agrees that the boat described below is of special design owned exclusively by Southern Fiberglass Products, LLC. Purchaser shall not allow any other person to and shall not himself, copy said design, take a mold from, or in any manner attempt to use same in any way whatsoever, for any purpose, without prior consent of Southern Fiberglass Products, LLC. Purchaser agrees that violating the terms of this provision shall be *prima facie* evidence of Purchaser's malicious, willful and flagrant appropriation of Southern Fiberglass Products, LLC property to his own use or to that of another person or entity not entitled thereto.

WARRANTY CLAIM PROCEDURES

Upon the discovery of a defect, the owner is to promptly contact Southern Fiberglass Products, LLC dealer from whom the owner purchased the boat, who will affect the corrective action under this warranty upon prior written authorization from Southern Fiberglass Products, LLC

THESE WARRANTIES ARE EXPRESSLY MADE IN LIEU OF ALL OTHER WARRANTIES, DURATION OF ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE OR OTHERWISE SHALL BE LIMITED TO AND CONINCIDENT WITH THE DURATION OF THESE EXPRESSED WARRANTIES.

THIS WARRANTY SHALL NOT BE VALID UNLESS THE FACTORY WARRANTY POSTCARD IS PROPERLY EXECUTED AND MAILED WITHIN 10 DAYS OF THE PURCHASE OF YOUR SOUTHERN FIBERGLASS PRODUCUTS, LLC BOAT.
